Other Conditions to Retain Driving Privileges:

	Parents will provide a safe and well maintained vehicle (this does not relieve the driver from the obligation to perform routine maintenance)
	Parents will coach the driver in a positive manner
	Parents will provide safe transportation if the driver (or as a passenger) is in such a position where they cannot operate the vehicle or are in an unsafe situation
	Parents will enforce the provisions of the graduated licensing restrictions including no passengers under the age of 20 (unless accompanied by an adult 25 years or older) and no driving between the hours of 11pm and 5am unless an exemption applies.

Other Assumed Responsibilities to Maintain Driving Privileges

- Driver will let parents know where they are going and stay within established boundaries
- Drivers will not make any modification to the vehicle (other than necessary repairs) without prior permission by parents (this includes stickers and modifications to the passenger area)
- Drivers are responsible to obey all parking laws
- Drivers will keep the vehicle clean
- Agreed upon vehicle maintenance will be performed (may include checking fluid levels, tire air pressure and fueling vehicle)
- Drivers will comply with all family and school rules

I also recognize that driver licenses are issued to those under the age of 18 by continuing permission of a parent or guardian and can be legally removed at any time by the parent or guardian without cause.
